## About Children of the Valley

Founded in 2006, Children of the Valley works in partnership with the Mount Vernon, Sedro-Woolley, and Burlington-Edison school districts to serve students K-5/6\* referred by a school teacher, counselor, or administrator for exhibiting substantial personal or academic need. We currently operate four sites with a total of 11 classrooms.

Free to the families and students we serve, our program provides daily instructor-led academic assistance, enrichment activities, and social-emotional learning opportunities, in addition to assisting families with meeting basic needs.

# A Community Rising for the Kids

## Dear COV Partners,

During my time as principal at Mount Baker Middle School, I was often frustrated about the need for students to have academic support and guidance between the school day and the time their parents came home from work. Many students were struggling academically, getting into trouble, and their behaviors spilled into the school day. I wished that somehow there could be a neighborhood safety net to gather them up and give them the help they needed.

Little did I know that at Centennial Elementary School a 3rd grade teacher, Mary Nolte, had that same vision. She shared the vision with a group of community leaders, and Children of the Valley was founded. Over the past 18 years, the number of children served and the investment from our community have grown tremendously.

This year, as I fulfilled my second and final term as COV Board Chair, I am in awe of the community support for COV. The large attendance and generous financial contributions raised at the auction were evidence of our Skagit community investing in lives of the children, families, and our future. # 2023-2028 Strategic Plan

## Roadmap for a Bright Future

With Children of the Valley sites and classrooms successfully underway in Mount Vernon, Sedro-Woolley, and Burlington, the Board of Directors established a five-year strategic plan to support and expand program operations. It is clear from waiting lists and community input that the need for COV is high and growing among all grades. With this need in mind, the Board of Directors identified three priorities to serve COV's strategic plan.



### Priority One • Fiscal Sustainability

Diversify funding to sustain site expansion and program fidelity.

- ♥ Increase our number of monthly donors.
- ♥ Expand our Leadership Circle
- ♥ Raise awareness of program needs to attract new financial support.

### Priority Three • Program Fidelity

Ensure that COV's mission and program integrity are maintained at each site and in each classroom.

- ♥ Create systems to gather data and monitor student progression on Cornerstones of Care.
- ♥ Provide infrastructure support in order to maintain program quality.

### Priority Two • Middle School Support

Expand vertically by developing a middle school component for student retention and academic success.

- ♥ Create support services for COV students moving onto middle school.

- ♥ Engage COV graduates to continue their connection to COV by volunteering.

*The number of our volunteers who are COV graduates is increasing. Additionally, we now offer monthly volunteer workshops to help prepare our youth for entering the workforce.*

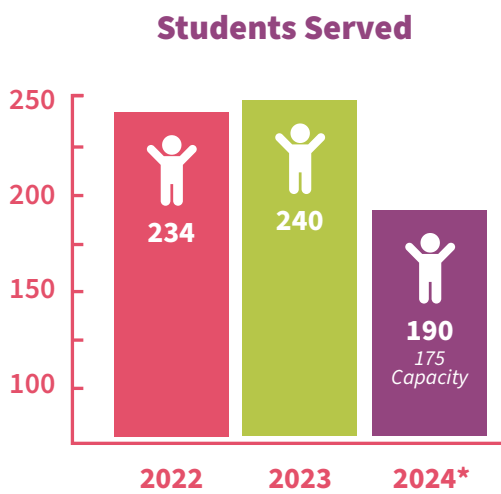
- ♥ **New Priority: COV Alumni Group**

# Who We Serve

## The Truth Behind the Numbers

A combination of school district budget shortfalls and the early expiration of COVID relief funds led to the closure of our Centennial Elementary site and the loss of four classrooms among our remaining sites, decreasing our program's maximum capacity to 175 children.\* **We are operating beyond maximum capacity**, with 50 referred children on our waitlist, some of whom have been waiting for several years. Additionally, many children who would attend our program cannot do so due to a lack of safe and reliable transportation home after programming. We are working diligently to increase our transportation services to bridge this resource gap for these children.

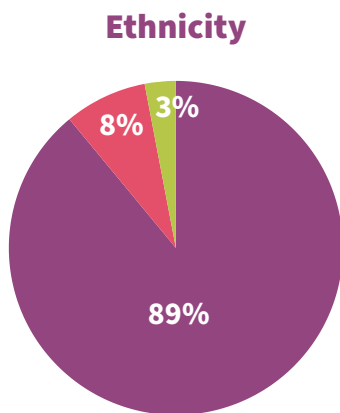

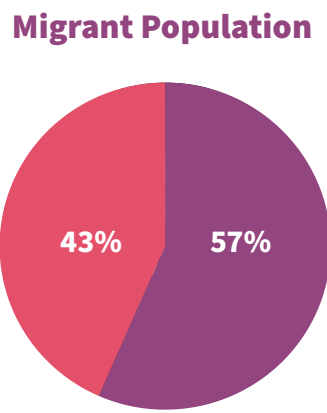

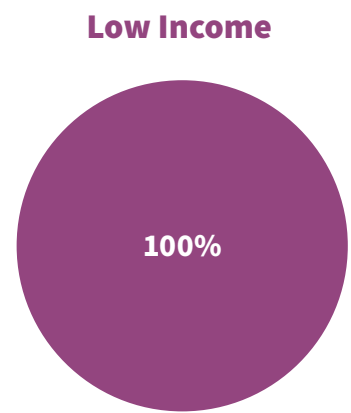

# What's New

## Middle School Bike Club to Launch Fall 2024

We are excited to announce that COV is partnering with Cascade Bicycle Club to start an after-school bike club in the fall for middle schoolers in the Mount Vernon, Burlington-Edison, and Sedro-Woolley school districts. In addition to learning how to safely and skillfully ride bikes through our communities, our middle schoolers will learn basic bike repair skills, bike laws, and the benefits of bicycling for health and transportation.

**Youth who participate in these after-school bike clubs will also have the opportunity to earn a bike of their own.** Funding for this bike education programming comes from Washington state's Climate Commitment Act, which supports the new School-Based Bicycle Safety Education Program created by the state Legislature and the Washington State Department of Transportation.

## Fleet Expansion for Safe Transportation

We are thrilled to expand our fleet with **two new vans**, ensuring safe and reliable transportation for field trips and rides home after programming. A heartfelt thank you to HF Sinclair, Puget Sound Energy, Peoples Bank, the Jansen Foundation, and the Boeing employee match program for their generous funding that made this possible.

# Academic Assistance

## COV Children Receive 1 Hour of Daily Academic Support

Through regular correspondence with teachers, we tailor efforts specific to each child's academic needs, helping them develop better study skills, increase knowledge of core classroom curriculum, and boost self-confidence.

- ♥ 30 minutes of daily reading support
- ♥ Academic games and activities
- ♥ Tutoring support with homework completion
- ♥ Regular communication with school teacher

## Attendance Improves with COV Participation

According to the Office of the Superintendent of Public Instruction (OSPI), "Attendance is a powerful signal and leading indicator of equity." **Students that miss just two days a month for any reason are more likely to not read at grade level, and more likely to not graduate."**

While the benchmark for regular school attendance is 90% in Washington State and nationwide, we're proud to report that 100% of COV children in the Mount Vernon School District had an average attendance of 92% during the 2023-2024 school year. And, **one-third of those students had an attendance rate of 98%!"**

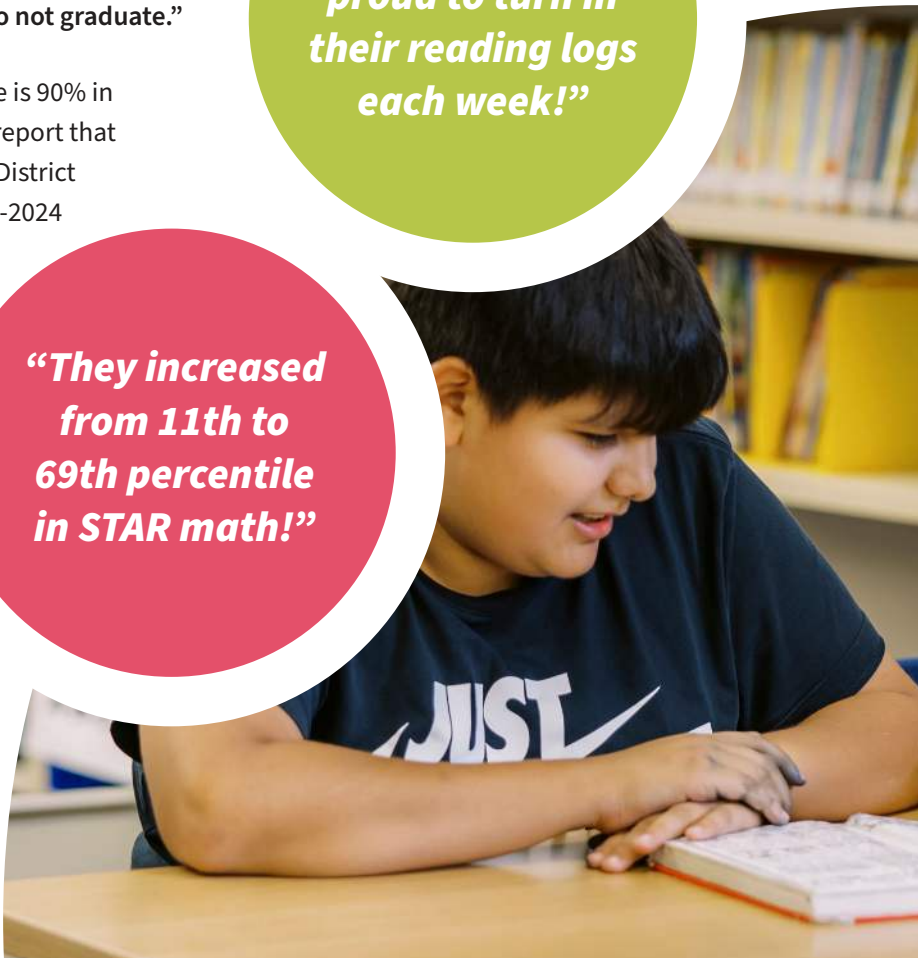

# Social Emotional Learning

## Supporting Children's Social-Emotional Well-Being for Enhanced Learning

A child's social-emotional well-being is one of the largest factors in their ability to learn. Our goal is to provide COV children with the necessary tools to understand and manage their unique, and often confusing, emotions.

Thanks to our partnerships with Skagit Valley Family YMCA's MV Hope Coalition and Sedro-Woolley Rise, COV uses **Positive Action**, a highly-studied and proven curriculum that teaches children how to control their emotions, put themselves in others' shoes, and practice self-care.

- ♥ COV staff attend annual Positive Action trainings
- ♥ COV children receive 15-30 minutes of daily S-EL
- ♥ COV staff taught a combined 389 hrs of S-EL during '23-'24 school year

### How has COV helped you and your family?

*COV has supported our family by helping with academics. It's a big help especially with a language barrier of only speaking Spanish. This program allows me to help my kids.*

### What positive impact have you seen in your children since attending COV?

*In a lot of different ways, it's helped my son, Niko, academically improve a lot in reading, writing and speaking skills. And with my other son, Noah, COV has helped with social-emotional skills like learning how to engage with others.*

### What is the biggest impact COV has had on your family?

*Above all, they are a great help for parents, like in my case, who don't know English. They help us with the children's homework, and to socialize more with other Latino children like them.*

# Mentorship

## Shaping Education Together

COV proudly partners with Skagit Valley College (SVC) and Western Washington University (WWU) to shape the future of education.

We collaborate with SVC's *Maestros Para el Pueblo* for work-based learning and employment, and this fall, SVC launched its *Nurturing Relationships* early childhood education course at COV, equipping future educators with essential skills like child safety, development, and culturally responsive teaching.

Through WWU's Compass 2 Campus program, aspiring educators volunteer at COV for hands-on classroom experience. Since 2021, we've also hosted WWU Human Services interns, some of whom have joined our team!

Together, we create a space where COV children dream big about their own college futures.

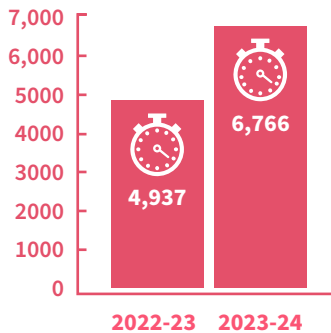
### What's your most memorable COV moment?

*I love seeing the friendships that each student builds with one another and how they look out for each other.*

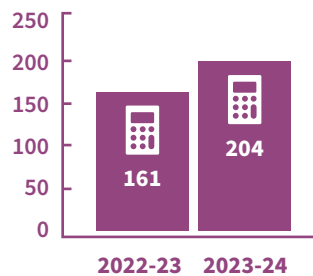

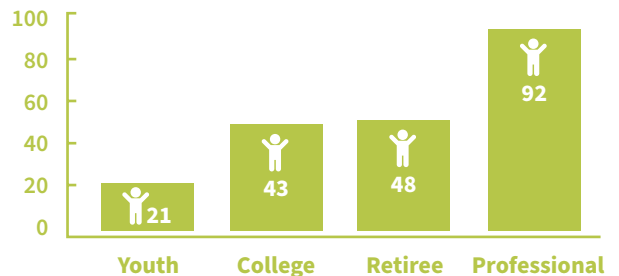
**Volunteer Hours**

**What was your life like when you joined COV?**

*My parents immigrated in 1989 to the Skagit Valley. I didn't have the resources at home to be able to get school work done, coming from parents that worked long hours and English wasn't their first language. Getting referred to COV by my school was one of the best things that could have happened to me.*

**What were the immediate impacts of COV on your life?**

*The immediate impact COV had was structure. Growing up I struggled with dyslexia, reading was a big struggle and they knew that and took that extra time to help me. COV gave me that safe place, making me feel like I did have a chance in this society from the start.*

**What were the lasting impacts of COV on your life?**

*I could never wrap my head around the fact that people I have never met would help me without even knowing me. They did it with the care from their heart. That will always stay with me and I will always be grateful.*

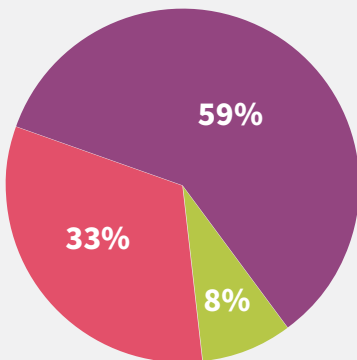


## Financial Overview
